MISS DIG 811 provides this free service to homeowners, excavators, municipalities and utility companies via our web based locate requests- [elocate.missdig.org](http://elocate.missdig.org) and [rte.missdig.org](http://rte.missdig.org), or by placing a toll free call to 811, 248-370-6400, or 800-482-7171. MISS DIG 811 processes that locate request by contacting our over 1,700 members, who then come out and locate their facilities. The mission of MISS DIG System, Inc. is to safeguard the public, environment, property, and utility infrastructures and promote utility damage prevention through a quality, cost-effective process for our customers.

### **It's the LAW and it's FREE!**

*It's the LAW?*

Yes, a bill was signed by Gov. Rick Snyder and has been in effect since April 1, 2014. Be smart and contact MISS DIG 811 before you dig.

*What do you mean FREE?*

When you contact MISS DIG 811, the public facility companies are notified to mark the location of their underground lines. Public facilities are marked for FREE by facility company representatives known as Locators. The Locators paint lines and/or place flags to mark the approximate location of underground public lines.

### **To Place a Dig Notice:**

1. Visit [newtin.missdig.org/e-suite](http://newtin.missdig.org/e-suite)
2. In the e-Locate box, click Start
3. Complete the e-Locate Request
4. Check your status before you dig at [newtina.missdig.org/newtinweb/gen\\_resp\\_inquiry.nas](http://newtina.missdig.org/newtinweb/gen_resp_inquiry.nas)
5. Enter your ticket #, click Inquire

### **5 Steps to Safe Digging:**

1. Call MISS DIG 811 at 811 or go online to [newtin.missdig.org/e-suite](http://newtin.missdig.org/e-suite)
2. Wait for utilities to be marked
3. Check status at [newtina.missdig.org/newtinweb/gen\\_resp\\_inquiry.nas](http://newtina.missdig.org/newtinweb/gen_resp_inquiry.nas)
4. Respect the marks
5. Dig with care
